STEP 1 – UNDERSTANDING THE "WHY"?



Your Case Officer is a delegate of the "Minister for Immigration, Citizenship, Migrant Services & Multicultural Affairs" (DOHA) and has responsibility to ensure your Partner Application meets the stringent Australian Immigration regulations & policy.

Every relationship is unique, and your Case Officer isn't a mind reader. They don't personally know you or your partner, so this means that it is your responsibility to share your personal love story with them.

DOHA expects you to provide personal ID, character documents such as Birth Certificates, Passports, Police Checks etc but it also very important to provide documentary evidence covering the duration and genuineness of your relationship.

What is your Case Officer assessing?

Your case officer needs to be satisfied that you:

- are a Spouse or De Facto Partner AND
- have a mutual commitment to a shared life to the exclusion of all others
- have a relationship that is genuine & continuing and
- live together or not live separately & apart on a permanent basis.

Each Case Officer should consider ALL circumstances of your relationship:

- Financial aspects of the relationship.
- Nature of your household.
- Social aspects of the relationship.
- Nature of the persons' commitment to each other.

Now that you both know the **WHY** your Case Officer needs documentary evidence of your relationship, the next Step is to start to think about **WHAT** documentary evidence is hidden away or filed amongst your emails, phone, drawers or boxes under your bed or in the cupboard.

STEP 2 – GUIDE PREPARATION.

- Share the workbook with your Partner.
- Please complete this GUIDE TOGETHER
- Grab a coffee, tea, wine or beer AND a pen

STEP 3 - IDENTIFY WHAT DOCUMENTS YOU HAVE & WHAT YOU DO NOT HAVE.

- Start with the "Financial" Aspect of your Relationship on Page 7
- Which documents in the left side are relevant to your Love Story?
- List them in the right hand side of the page.

STEP 4 - ASK EACH OTHER WHO HAS & WHERE ARE THE DOCUMENTS?



- WHO has this evidence?
- WHERE is the evidence?
- Is it possible to get evidence that you didn't keep?
- HOW can we do this?
- WHO & HOW can we contact them?

Now that you located the evidence that you have, let's consider your personal circumstances. WHAT evidence is not available or not relevant. Each relationship is unique so not all evidence is required for your personal circumstances.

STEP 4 – continuation ...

Consider your personal circumstances:

- Are you living together in Australia or living Oveseas?
- Do you have children together?
- Are you Engaged?
- What other factors are relevant to your relationship?

Identify & list any additional or new relationship evidence in the "Action Plan" on page 14

Fantastic! You have done well to finish the first aspect. Congratulate yourselves on the effort. I wonder if you have already found new evidence of your relationship?

Now repeat this process ie Steps 3 & 4 with each Aspect or Pillar of your Relationship.



Step 5 is to be completed AFTER you have worked through the four aspects or pillars of your relationship.

STEP 5 - PREPARE & ATTACH THE EVIDENCE TO YOUR IMMIACCOUNT



Preparation of your Documentary Evidence:

- Translate into English eg https://www.naati.com.au/
- Collate & Colour scan each document
- Name the file so it describes the content
- Under 5MB size to attach to your ImmiAccount



Attach Documents to your ImmiAccount under the relevant Headings eg:

- Contact while apart
- Couple are living together
- Nature of couple's mutual commitment to each other
- Nature of Couples Household
- Relationship Spouse, De facto Partner

If you can't find a relevant Heading attach the document under "Other".







You have now completed the "The 5 Step Document Evidence Guide."

You will now have additional documents providing evidence of your relationship covering the four aspects or relationship pillars that will help the case officer make a decision on your Australian Partner application.



Additional requirements:

Form 888 - two declarations

To be completed by person at least 18 years of age. An Aussie citz or PR, Known by both applicant & sponsor Signed & witnessed.

Relationship Statements to be completed by Applicant & Sponsor



Case Officers will take into consideration the visa application as a "whole" so it's important that the documentary evidence of your relationship is comprehensive, relevant & shows the duration of your relationship.

Your love story is unique so there isn't necessarily a "one size fits all" solution. Providing documentary evidence of your relationship can be complicated and IF you're unsure or have questions then it is in your best interests to contact a registered migration agent to discuss your personal circumstances.
